# CITY OF WELDON SPRING REGULAR MEETING OF THE BOARD OF ALDERMEN FEBRUARY 22, 2018

**CALL TO ORDER:** The regular meeting of the Board of Aldermen of the City of Weldon Spring was held on Thursday, February 22<sup>nd</sup>, 2018 at approximately 7:30 P.M. The meeting was held at the Weldon Spring City Hall, which is located at 5401 Independence Road. The meeting was called to order by Mayor Donald Licklider.

**PLEDGE OF ALLEGIANCE:** All present stood for the Pledge of Allegiance.

**ROLL CALL AND DETERMINATION OF QUORUM:** The following Aldermen were present: Kolb, Schwaab, Kohrs and Robb. A quorum was declared.

#### **APPROVAL OF MINUTES:**

\*\*\* Alderman Kohrs moved to approve the minutes from the February 13<sup>th</sup>, 2018 meeting as submitted and Alderman Robb seconded the motion. The motion carried.

#### **PUBLIC FORUM – CITIZENS COMMENTS:**

### **PUBLIC HEARING:**

A PUBLIC HEARING IS BEING HELD IN ORDER TO CONSIDER ADOPTION OF AMENDMENTS TO THE CITY CODE TITLE IV (ZONING & SUBDIVISION REGULATIONS – CHAPTER 400-410) AND ADOPT THE OFFICIAL ZONING MAP. THE PROPOSED REGULATORY AMENDMENTS ARE BEING PROPOSED TO MAKE THE CITY'S LAND USE REGULATIONS CONSISTENT WITH THE CITY'S 2015 COMPREHENSIVE PLAN AND ADDRESS THE LATEST ZONING AND REGULATORY PRACTICES. THE PROPOSED ZONING MAP UPDATES ARE BEING PROPOSED TO CONVERT THE MAP TO THE LATEST GIS SOFTWARE (NO CHANGES TO THE CURRENT ZONING DISTRICT BOUNDARIES ARE PROPOSED).

\*\*\*Mayor Licklider opened the Public Hearing and asked if anyone wished to speak. No one spoke, so Mayor Licklider closed the Public Hearing.

## TREASURER'S REPORT:

\*\*\* Alderman Schwaab moved to approve the Paid Bills for the period covering February 8<sup>th</sup>, 2018 through February 15<sup>th</sup>, 2018 as submitted. Alderman Kohrs seconded the motion and the motion carried.

A.) – BILL #1105 - AN ORDINANCE OF THE CITY VACATING CERTAIN
PORTIONS OF A SIDEWALK WITHIN CAMELOT SUBDIVISION AND MATTERS
RELATING THERETO – (Ald. Kolb)

\*\*\* Alderman Kolb moved to read Bill # 1105 for the second and final time. Alderman Robb seconded the motion and the motion carried.

Roll Call: Kolb-yes, Robb-yes, Schwaab-yes, Kohrs-yes, Hillmer-absent and Baker-absent.

Bill # 1105 passed becoming Ordinance # 18-02.

#### **NEW BUSINESS:**

A. - HR GREEN -SUPPLEMENTAL AGREEMENT #2 – (**Discussion/Motion**) No action taken.

B. – AN ORDINANCE OF THE CITY OF WELDON SPRING AUTHORIZING AND DIRECTING THE SUBMISSION OF A BALLOT PROPOSITION TO THE QUALIFIED VOTERS OF THE CITY TO CONSIDER IMPOSING A LOCAL USE TAX AT THE SAME RATE AS THE LOCAL SALES TAX OF THE CITY FOR PURCHASES FROM OUT-OF-STATE VENDORS THAT EXCEED A TOTAL OF TWO THOUSAND DOLLARS IN A YEAR – (Ald. Robb)

\*\*\* Alderman Robb made a motion to introduce Bill # 1106 for its first reading and Alderman Kohrs seconded the motion.

Bill # 1106 was tabled in accordance with City Code.
