PUBLIC COMMENTS: There were no public comments at this time.

MINUTES: May 11, 2021, Board Minutes - Alderman Baker moved to approve the minutes from the May 11, 2021, regular meeting as written, seconded by Alderman Schwaab. Motion carried with 6 ayes.

TREASURER'S REPORT: Alderman Baker made a motion to accept the Treasurer's packet of paid bills from May 1, 2021, to May 12, 2021, seconded by Alderman Schwaab. Alderman Kolb questioned the \$599.00 charge from Critter Control. Mayor Licklider stated it was the removal of squirrels in the attic at City Hall. The **motion carried** with 6 ayes.

He also informed the Board that the Committee will review the data from the Communitywide Survey at a future meeting.

Alderman Baker added that the Finance Committee has requested that PRAC give input and prioritize their projects for the five-year financial plan by this summer.

City Attorney Report: Mr. Wohler (City Attorney) gave an update on potential litigation.

Legislative Report: The Legislative Report was included in the meeting packet.
