

Chapter 210. Offenses

Article XV. Miscellaneous Offenses

Section 210.2470. Deposit Of Snow Or Ice In Certain Public Improvements.

[Ord. No. 21-05, 5-11-2021]

- A. All commercial businesses, commercial property owners, or persons employed or under contract with said owners, within the City limits who are engaged in the removal of snow, ice, or other frozen precipitation shall not allow such snow, ice or other frozen precipitation to be deposited on the sidewalk, walking path, street, or anything for public use. Nor shall any person or persons engaged in the removal of snow or ice allow such snow, ice or other frozen precipitation to be deposited on or against any fire hydrant.
- B. Any commercial business or commercial property owner who fails to comply with, or commits any violation of, any provision of this Section, whether said act is done by the owner or by persons employed or under contract with the property owner, shall be charged with an ordinance violation, which shall be punishable, upon conviction thereof, pursuant to Section 100.220, General Penalty, in the Weldon Spring Municipal Code. This fine shall be in addition to any other remedies prescribed in this Code or ordinances of the City or the laws of the State; and each day such failure to comply or such violation continues shall be deemed a separate offense.

 - Keeping pollutants out of our waterways
 - Polluted stormwater runoff can be transported to municipal separate storm sewer systems (MS4s) and then discharged into local rivers and streams without treatment. Common pollutants include oil and grease from roadways, pesticides from lawns, sediment from construction sites, and carelessly discarded trash, such as cigarette butts, paper wrappers, and plastic bottles. When deposited into nearby waterways, these pollutants can impair waterways, thereby

- discouraging recreation, contaminating drinking water supplies, and degrading the habitat for fish, other aquatic organisms, and wildlife.
- It is everyone's responsibility to keep these pollutants out of water systems. Regular maintenance of vehicles and equipment, proper disposal of chemicals and refuse, proper use of pesticides and fertilizers, and cleaning up after pets are imperative. Please help keep our water clean by doing your part!

Code Spotlight

- O In the coming months the Board of Aldermen will review and potentially approve a new ordinance outlining property owners' responsibility to maintain grass to the curb of any public street. A draft of this ordinance is printed below:
 - It shall be the duty of the owner of any lot, tract, or parcel of ground abutting upon or laying adjacent to any public street within the City to level or fill the space between the curbstone and the sidewalk with suitable soil or dirt to grow grass. Such a parkway shall be sowed in grass, kept mowed, and in good condition by the abutting property owner. *

- Weldon Spring City Hall Facility Needs Assessment 2.0
 - The elected officials and City Staff have received a second Facility Needs Assessment from Navigate Building Solutions. This assessment is more indepth than the previous report and addresses current conditions and staff space needs.
 - The current building is a 3,325 sqft home adapted to be offices and a 2,250 sqft basement used for storage, totaling 5,575 sqft. The new assessment reiterates the 2024 study: The current building is inadequate for the City's current and future needs. The study's recommendation is for a building that is 26 percent larger, totaling 7,000 square feet (sqft).*

- The Study also provided construction estimates for renovation, expansion, or a new City Hall construction.
 - The Estimates are as follows:

Renovate City Hall: \$2,000,000*

Renovate and Expand City Hall: \$3,000,000*

Build New 7,000 sqft City Hall: \$4,250,000*

- Senior Real Estate Property Tax Freeze Relief Program
 - The City of Weldon Spring does not have a property tax for real estate or any other property. This is a St. Charles County Program; City Staff cannot assist with or accept applications. For more information about applying, please visit sccmo.org/2343/Seniors-Real-Estate-Property-Tax-Relief or call the revenue collector at 636.949.7470.
 - o Program Details 2025
 - The senior citizen real estate property tax relief program applies to the primary residence of St. Charles County residents at least 62 years old as of January 1, 2025.
 - Eligible residents must apply for the tax relief program annually to keep their tax amount frozen.

- The tax relief program began in tax year 2024 and does not apply retroactively to dates before that year.
- The tax relief program applies to all taxing jurisdictions within St.
 Charles County (ambulance districts, fire districts, school districts, cities, etc.) and not just to the part of the property tax bill that goes to the county itself.
- The application period for the 2025 tax year is March 1-June 30, 2025.
 Applications will be available in person, online, and by request through mail.
- Your tax dollars are at work: The 1% Sales tax for roads and police benefits residents, businesses, and the Police in Weldon Spring.
 - Speeding on City Roads
 - The City of Weldon Spring has a radar speed detector that staff places on public streets. This tool not only tells drivers their speed but also tracks data for analysis. When there is a noticeable increase in speeding drivers, City Staff asks police to patrol those areas during those times.
 - o LPR Traffic Safety Cameras
 - License Plate Reading (LPR) Cameras assist Police investigations in Weldon Spring and beyond. These Traffic Safety Cameras have assisted St. Charles County Police on multiple occasions, leading to arrests. The cameras can track a suspect's vehicle by reading their

license plate and communicating that information to police. This information puts the suspect in a specific area at a specific time or shows areas a suspect may frequent.
