CITY OF WELDON SPRING REGULAR MEETING OF THE BOARD OF ALDERMEN JUNE 28, 2018

CALL TO ORDER: The regular meeting of the Board of Aldermen of the City of Weldon Spring was held on Thursday, June 28th, 2018 at approximately 7:30 P.M.
